The victim became aware of the scam when she discovered an additional \$2,990 was removed her account.

**Fraud** at the 2600 block of Belmont Avenue on 8/19 @ 1557 hours – Victim received an email from someone claiming to be from PayPal regarding a fraudulent charge. They advised her to authorize them remote access to her computer so she could be reimbursed. The victim entered the amount \$350 to be refunded but they changed it to \$35,000 and advised her to return the money via a wire transfer.
