## TO: ALL RESIDENTIAL, COMMERCIAL AND INSTITUTIONAL ESTABLISHMENTS

Dear Commercial and Institutional Businesses:

As a requirement in the Township of Haverford, all commercial or institutional establishments in the township, as defined by the Pennsylvania Municipal Waste Planning, Recycling and Waste Reduction Act of July, 1988, Act 101 are required to recycle.

§95-26.5 Separation of recyclables at commercial or institutional establishments.

[Added 12-9-1991 by Ord. No. 2131)

All persons, as defined by the Pennsylvania Municipal Waste Planning, Recycling and Waste Reduction Act of July 1988, Act 101, w shall be required to separate high-grade office paper, aluminum, corrugated paper (cardboard) at commercial or institutional establishments in accordance with Section 1501(c)(1)(iii) of Act 101.m (Effective date

September 1990.) and other materials deemed appropriate by the municipality; i.e. glass and plastic bottles and bimetallic cans.

Failure to comply and not recycle will result in the following:

§ 95-26 Violations and penalties.

Any person, firm or corporation violating any provision of this article shall, upon summary conviction before any District Justice of the Peace, paya fine not exceeding \$1,000 and costs of prosecution; and in default of one payment of the fine and costs, the violator may be sentenced to the county jail for a term of not more than 90 days. Each and every day in which any person, firm or corporation shall be inviolation of  $\S 95-25$  shall constitute a separate of fense. Your cooperation is appreciated.
