



## **Important Information From PECO: Upcoming Gas Main and Bare Steel Service Replacement**

*See below for information about how this may affect your neighborhood.*

We are all aware and frustrated by the ongoing utility work in Haverford Township and beyond. It seems that, no matter where you turn, there is a utility project blocking the way. In fact, there are a number of current projects that require final restoration by PECO. These ongoing projects include the Paddock Farms neighborhood, Rockwood Drive, Merion Golf Manor and the Campbell Avenue vicinity. We expect final restoration in early spring, weather permitting.

PECO has announced plans to continue replacing existing natural gas mains and related equipment throughout the region during 2022. This will include new underground pipe made of modern materials, which is more durable, enhances safety and improves service reliability. As part of this Bare Steel Service Replacement Program (BSSR), PECO will replace bare steel gas service lines with plastic due to risks associated with material age and degradation. This is part of PECO's larger commitment to the Pennsylvania Public Utility Commission aimed at preventing future gas leaks and mitigating risk within the PECO Gas system. According to PECO, this work is critical to the safe and reliable gas service that we have grown to appreciate. PECO's schedule for 2022 is particularly aggressive, and there will be additional gas main work for years to come.

PECO has already started notifying residents of work that will affect them. ***See below for affected areas in Haverford Township.*** The majority of the BSSR work will be outside of the home. Work may occur on streets, sidewalks and, in some cases, on private property. Of course, PECO is required to restore all areas upon completion of their work.

To ensure the work is completed safely, PECO and their contractors will need to turn off natural gas service temporarily (4 to 8 hours) to some residences during the process. To do so, PECO will contact residents to schedule an appointment. PECO will need access to the natural gas appliances and equipment in your home early in the day; later in the day PECO will need to restore service and relight any appliances. Also at this appointment, PECO will relocate any indoor natural gas meters to the exterior of customer homes. This relocation work is necessary

for the safety of PECO employees, contractors, customers and communities and is mandatory per the Pennsylvania Public Utility Commission.

**It is very important that residents work with PECO if contacted for an appointment. This will allow PECO to complete the work, including all restoration, as expeditiously as possible.**

As always, if you suspect a leak or smell gas inside or out, leave the area immediately. Then call PECO's emergency line from a safe location. Don't use matches or turn anything on, including cell phones. Even homes not using natural gas can experience gas leaks from outdoor equipment. If you smell natural gas, please call PECO at 1-800-841-4141.

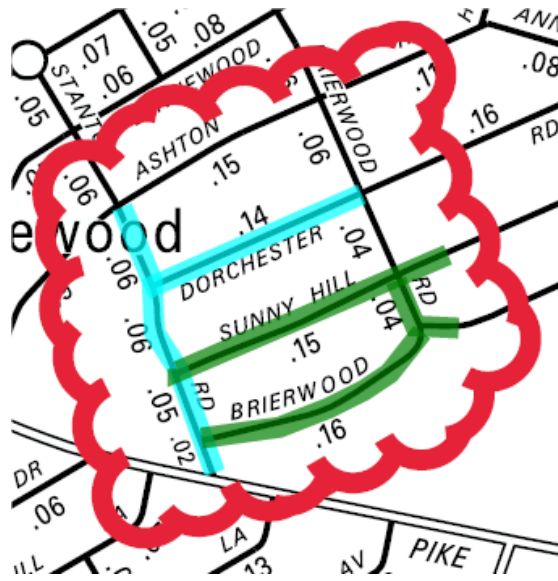
### **Schedule**

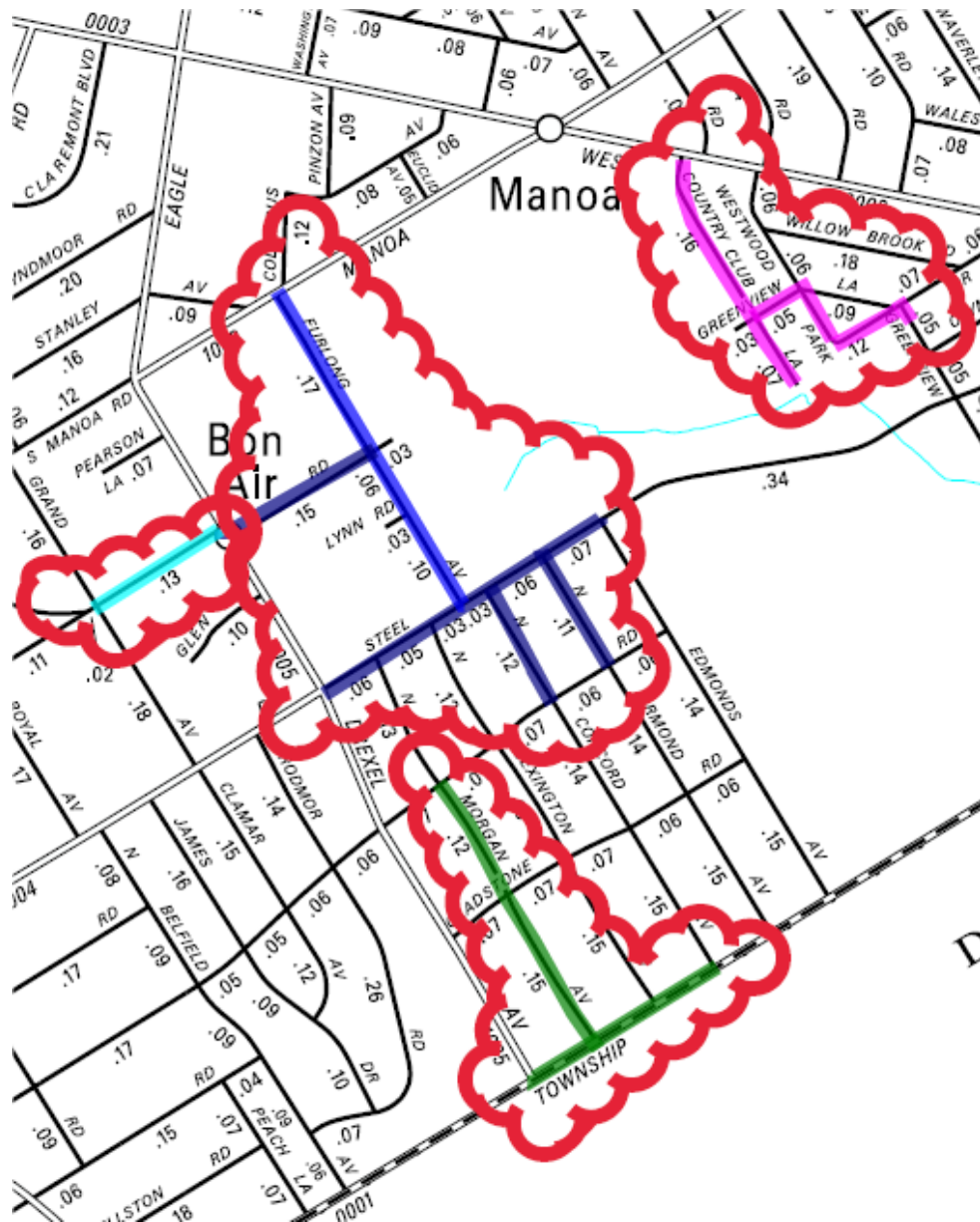

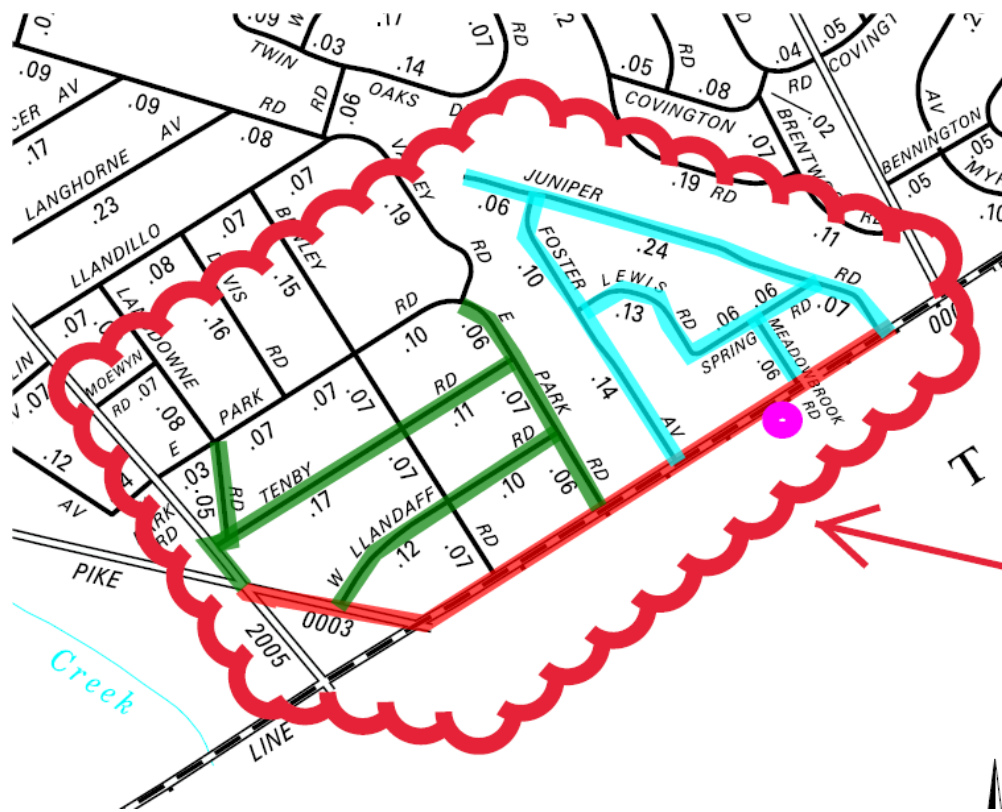
