COMPREHENSIVE PLAN

The Comprehensive Plan: A "vision board" for the future of Haverford Township.

Much like a personal vision board, a municipal Comprehensive Plan identifies goals for future growth and development, outlines challenges facing the community, identifies potential solutions, and provides guidance on future community planning-related decisions.

Our township is substantially developed, and the public input that we've received (by way of questionnaires, surveys, public workshops and public meetings) found that many residents do not want to see any changes to their neighborhoods. Therefore, the Plan recommends to preserve our residential areas, and emphasizes a few areas in the township that are most subject to change.

These recommendations include the revitalization of older business areas (such as Haverford Road and Eagle Road), protecting important natural features, promoting environmental sustainability, preserving important historic buildings, and becoming more bicycle-friendly and walkable. No condemnation is proposed.

When completed, this document is intended to help guide future regulations. Adoption of the Plan does not result in any changes to the Zoning Map, Zoning Ordinance, and/or Land Development Ordinance. Any proposed amendments will be subject to a similar process including public meetings before the Planning Commission, public hearings before the Board of Commissioners, and eventual public vote for adoption by the Board of Commissioners.

The Planning Commission has finalized their recommendations regarding the Comprehensive Plan and has forward their comments to the Board of Commissioners. The Board of Commissioners will hold a Public Hearing and accept public comment prior to consideration. The date of the hearing has not been determined at the time of this writing, however, we anticipate the matter will be heard in January 2023.

SINGLE-USE PLASTIC

he purpose of this Ordinance is to reduce the impact of single-use plastics bags, straws and stirrers on our environment. This small change can be very impactful to the health of our local parks, streets, streams, rivers and waterways. Starting January 2, 2023, bring re-useable (or otherwise compliant) bags when shopping in the Township or businesses are required to assess a "per bag" fee to supply the customer with a compliant bag.

The Police Department would like to remind motorists of safe driving tips during the winter.

• Clear your windshields of frost/snow prior to driving.

• Drive slowly in the winter—it takes longer to slow your vehicle on an icy, wet or snowy surface.

• Allocate extra travel time during the winter to Ofc. Valvardi with K-9 Officer Barr compensate for driving more slowly. Do not rush or put yourself in a situation where you feel pressured to rush or speed.

• Make sure your vehicle is fully stocked with windshield wiper fluid with de-icer. Check regularly—this fluid can be depleted significantly by even one snowstorm.

• Make sure your defrosters and windshield wipers work and replace the blades if they have become worn.

When shoveling and plowing snow from your sidewalks and driveways, do not put the snow in the street. Placing snow in the street delays the clearing of the streets and is also a violation of

township ordinance.

Always remember to lock your car doors at night and call 911 immediately to report suspicious activity.

HISTORIC PLAQUE PROGRAM

omething that many of us appreciate about Haverford Township is the strong sense of place in our neighborhoods. A big contributor to this feeling is the character of our built environment, which traces the historical development of our township. Preserving this history and character was the primary goal in 1997 when the Haverford Board of Commissioners approved a survey of historic township properties that should be preserved, and passed the first preservation ordinance. The Commissioners revised the preservation ordinance in 2009, and created the Haverford Township Historical Commission. In addition to reviewing proposed exterior alterations to historic properties that were identified in the 1997 Historic Resources Survey, the Commission actively promotes recognizing and preserving the historic character of our neighborhoods. To make our historic properties more visible, the Historical Commission has been working on a new Historic Plaque Program, similar to programs in historic communities around us. Property owners will be able to purchase and display specially-designed bronze metal plaques on their building to identify its historic importance. The program was researched and developed over the past year and will be presented to the Board of Commissioners for review soon. We look forward to the debut of these plaques!

HOW TO BE STORMWATER SMART



Winter snow often puts a pristine white coat over every surface that makes for beautiful photos and lots of family fun. However, just like when rain falls the rest of the year, melting snow turns into stormwater runoff.

It is not long after the sun comes out and starts melting the snow, that concerns emerge. Even a small amount can cause localized flooding on your property, when it builds up over several small storm events without melting in between. When it finally does melt, runoff can lead to potential community wide flooding events. In both cases, standing and flowing water on the ground picks up all kinds of debris, pollutants, and litter that will find its way into nearby streams.

When shoveling/plowing snow this season, pay attention to where you place it:



- Pile snow in locations with the most opportunity to infiltrate into the ground.
- Pile snow in areas where water does not pond.
- Clear away any snow that may have been thrown onto the storm drains.
- Clear your downspouts to allow melting roof snow to flow and not collect at your foundation.

Pay special attention to places that are eroding during snow melt. Make a plan to improve these areas in spring, using plants that can slow and stop erosion, such as native grasses and meadow plants or native trees and shrubs.



- Do not pile snow on top of storm drains or near water bodies and wetlands.
- Do not pile snow onto rain gardens or bio retention areas.
- Do not overuse de-icing chemicals and salts and avoid spreading around sensitive areas like waterways.

Also remember - more salt does not equal more melting snow. Follow product instructions when spreading deicing material and give it time to work. Sweep up any material remaining after the snow/ice melts to help reduce pollution.

BUDGET TIPS FROM SURREY SERVICES

s the saying goes, a little thing can mean a lot. That is especially true for personal finances. Making small changes and sticking to those can really impact your overall budget especially for older adults living on a fixed income.

If you have difficulty saving, try one of these tips. Treat this fund like a bill. Contribute to it every month. Or, put this fund where it's not easy for you to dip into. Open a separate savings account that isn't linked to one you use regularly.

Putting services on autopilot: It's a great convenience to set your cable, telephone and other services on autopayment. However, you should review these bills on a regular basis. You may find that free services bundled into your contract have converted to fee based services that are added to your bill each month.

lewer backups and flooding can cause devastating property damage and are not covered by standard homeowners' insurance policies. The majority of these claims are the responsibility of the property owner.

Sewage from sanitary sewer lines occasionally back up into houses through drain pipes. These backups not only cause extensive water damage that is difficult and expensive to repair, but also creates health hazards.

Haverford Township is not responsible for damages caused by sewers, drains and sump pumps except under limited/special circumstances provided by the PA Municipal Immunity laws.

Township residents must be aware that they should review their homeowner's, flood and sewer backup insurance coverage with their agent/insurance companies in order to properly protect their personal residence probably the most valuable tangible asset that we all have.

Article I, Section 149-3, subsection C (2) Sewer Service Regulations of the Township Code states that all sewer service laterals from the Township's sewer, regardless of location, are the property of the customer and/or owner and shall be maintained by him in good condition and repair. Please pay particular attention to the following coverages: Coverage for Sewers, Drains and Sump Pumps: This valuable coverage is not included under your standard

homeowner's policy but can be purchased by endorsement for an

additional premium.

Flood Coverage:

Flood coverage is not included under your homeowner's policy. However, flood insurance is available under the National Flood Insurance Program (NFIP) and can be obtained through your insurance agent or broker.

The Township does not provide flood insurance.



SOLAR INF

f you pay ~\$100/mo. for electricity, that's \$30,000 over 25 **⊥** years! Instead, you can install solar on a sunny roof now, break even in about 8 years, and have about \$20,000 extra in your pocket by year 25 – a great return on investment. Home installations are typically \$15,000-\$25,000 depending on size and are eligible for a 30% tax credit, increased by the Inflation Reduction Act. Loans and no-money-down leasing options are available but take longer to pay back. It is best to avoid telemarketers and deal with local contractors or get unbiased information from local volunteers to help you assess your home and connect you with vetted installers with fixed lower pricing. The best time to install solar is when you have a new roof, but these systems last about 30 years and can be installed on roofs with 20 years of life remaining. Little or no maintenance is required on residential solar systems. The new Inflation Reduction Act also provides 30% tax credits for energy efficient heat pumps, air conditioners, water heaters, etc. as well as up to \$7,500 for electric vehicles. 2023 OPERATING BUDGET

n December 12, 2022, the Board of Commissioners adopted the 2023 Operating Budget and 2023-2026 Capital Improvement Plan. The 2023 budget included a 1.8% real estate tax increase to 4.295 mills (after 2 years without an increase) and a \$8 annual increase in the trash & recycling fee to \$283/yr which was largely due to price volatility in the recycling market. The sewer rate remained unchanged at \$4.65/1,000g of water used.

Our 2023 budgeted revenues are sourced as follows:

he \$49.9m general operating budget will fund all of the municipal services provided to our residents including administrative services, police, emergency medical, fire protection, code enforcement, zoning, highway maintenance, snow removal, curbside leaf removal, sanitation/recycling/brush collection (including bi-annual e-waste and shredding events), tree maintenance, maintenance of our street lights and traffic signals, maintenance of our extensive park system, offerings at the CREC, library operations, year-round recreational programming, preservation of historic buildings, debt service and programs offered at the Skatium.

2023-2026 CAPITAL IMPROVEMENT PLAN

mong the capital projects included in the 2023-2026 capital improvement plan include the extensive library renovation, emergency apparatus replacement, streetscape projects, improvements to stormwater and sanitary systems, park improvements, continuation of the Pennsy and Darby Creek trails, road paving, neighborhood traffic and pedestrian safety improvements, improvements to the public works yard and a new software system to better manage constituent concerns. Our residents will hear more details about these and other projects at public Board of Commissioner meetings before contracts are awarded.

Township management is always looking for opportunities to improve efficiencies in our operations. We are in a unique business of providing community services specifically meant to enhance the quality of life of residents, businesses, and visitors and we hope the 2023 budget is seen as responsive to those needs!

averford Township Police Department extends well wishes to Sgt. Christopher Chambers upon his retirement. Sgt. Chambers served for over twenty-five years in both Patrol and Investigations Divisions.

Haverford Township has recently experienced an increase in thefts from autos, mail thefts, and scam attempts. Residents are encouraged to take a few steps in order to better protect themselves from these potential crimes.

If possible, park your vehicles in your driveway. If you have to park on the street or in a public place, consider parking in an area with good lighting, remove all valuables from the vehicle, lock your doors, and never leave your key or fob in the vehicle.

One way to protect yourself from mail theft is to hand deliver your mail to the post office or hand it directly to your letter carrier. This eliminates the opportunity for thieves to remove your mail from mailboxes on the street or even at your home!

Almost anyone is susceptible to scam attempts these days. Residents are reminded government agencies will not contact you by phone and instruct you to conduct any financial transactions over the phone.

Remember do not hesitate to call 911 to report suspicious activity while it is in progress. Officers will respond and investigate accordingly. It is safer and easier for the community to have something that "just doesn't look right" checked out today, rather than wait for tomorrow only to find a problem that could have been addressed sooner.

WELCOME TO Spring Season!

As the weather becomes warmer, there is a tendency to want to make our outdoor living areas more livable. Often times, we are in a rush to start our "To-Do" projects that have grown over the winter months without much of a second thought.

Did you apply for and receive a permit or even know whether a permit was required? A permit is required for new construction, additions, alterations, and any project that requires structural changes. Building permit applications are available on the Township website or at the Township office. Check with the Community Development Department before you make alterations to your home or business. Here are some improvements that require permits:

- Fences or walls
- Structural repair or replacement
- Sheds, Greenhouses
- Fireplaces
- Wood deck, patio, porch
- Alternative Energy Systems
- Swimming pools, spa or hot tubs. over 24 inches in depth
- Changes in use, home occupations, change in commercial tenants
- New building construction and additions
- Heating and air condition replacement or installation
- Roof replacement
- Plant, prune, remove or spray a public shade tree
- Plumbing alterations
- Electrical work or new installation
- · Interior alterations
- Signs

nring Fire Safety Tips

During your spring cleaning do not forget to add these important items to your "To-Do-List".

Inside Safety Tips:

- Test your smoke and carbon monoxide detectors, change batteries immediately if needed.
- Check for overloaded or damaged extension cords, and replace where needed.
- Properly store household chemicals and never mix cleaning agents.
- Recycle: Get rid of old newspapers, magazines, and junk mail. These items tend to pile up and can greatly contribute to the severity and spread of a fire.
- · Check and clean filters above the stove.
- Pull the refrigerator out and vacuum or dust the coils.

Outside Safety Tips:

- Maintain a clear "fire zone" of 10' around structures.
- Check outdoor electrical outlets and other electrical appliances for animal nests and to ensure proper wiring.
- Remove leaves and trash from carports and garages: Combustible materials are dangerous if they are exposed to heated automobile components, especially under the vehicle.

ulk Trash and Brush Collection Reminders:

- Articles may not be placed in front / side of the property to be given away (e.g., furniture, appliances, large items). Pre-payment and registration is required by visiting the Township Building or can be done online.
- Collections take place on Wednesdays and can take up to 48 hours for the collection to be completed. Items must be placed at the curb by 7:00 AM Wednesday mornings. If items are still left by end of day, the items will be collected the following day.
 - •The Township's brush site CAN accept only: untreated wood products such as sticks, branches, brush or wood chips.

PLEASE NO litter, trash, garbage, bamboo, dirt/soil, leaves or grass clippings, kitty litter or pet manure. No bags, not even biodegradable bags, twine, no container in excess of 40 lbs., no branches over three feet in length no branches over 1 ½ inches in diameter.

Stormwater is runoff that comes from hard surfaces including roofs, walkways, driveways, and lawn grasses. The stormwater that leaves our properties enters the storm sewer system where it is discharged into our local waterways. Runoff can carry pet waste, oil, fertilizer, road salt, pesticides, and large volumes of water into our streams. These lead to reduced water quality and flooding. Taking small steps to manage some or all of the stormwater on your property can improve water quality and reduce flooding.

Steps to include:

Replacing lawn areas with native plants
 Planting trees and shrubs
 Installing rain gardens, rain barrels and/or downspout planters
 Reducing the use of fertilizers and road salt
 Picking up pet waste that can be washed into the street
 Fixing any leaks from automobiles

With approximately 17% of our Township population in the 65 and over age group, our Police Department is seeing more scams perpetrated upon them so we are creating a 2-part article series. The top most common scams against seniors were identified below as we begin with

Part 1 of the series with Identifying Scams

1. Grandparent Scam

Fraudsters call claiming to be the senior's grandchild who needs money for an emergency. There is distortion on the line and voices cannot be clearly heard so the senior may believe the grandchild really needs help. The scammer most often represents himself as a law enforcement officer. He/she will tell the senior to purchase gift cards (i.e., Visa, Amazon) to make needed auto repairs or pay a bail bond.

2. Imposter Scam

Fraudsters call and claim they are from the IRS or Social Security Administration and tell the senior they owe back taxes and or penalties and to provide a credit card number to pay.

3. Computer Scams and Phishing

Phishing is when a fraudulent email or a text message is designed to trick a person into revealing sensitive personal information to the attacker. Many of these scammers may impersonate trustworthy organizations like your bank, etc. This is by far the most common attack performed by cybercriminals and can result in identity theft.

4. Sweetheart Scams

Internet dating sites and social media offer fraudsters opportunities to scam seniors looking for love. The new romantic interest gains the trust of the senior and then starts to request money be sent electronically for an emergency or for travel expenses to meet in person.

5. Property Scams with Services

Fraudsters target seniors and try to sell them home improvement services that are never delivered. The fraudster takes the money and never return it.

Step 1 is Learning to Identify! We'll visit Step 2 in our next newsletter with methods on how to protect yourself from these top 5 scams. If you fall victim, call 911 to report the crime, and don't ever feel embarrassed. The 911 center will then route the call to our Haverford Township Police which works in partnership with the County DA's Senior Exploitation Unit. If you have any questions about a senior scam, you can simply call the non-emergency number of the Haverford Police Department at 610-853-1298 and our officers and staff will be happy to assist.

HAT IS FAIR HOUSING? Fair housing is the right to choose housing free from unlawful discrimination. Federal law protects people from discrimination in housing transactions such as rentals, sales, lending, and insurance. Fair Housing is the key to all people having the roof they want over their heads.

WHO IS PROTECTED?

The Fair Housing laws protect discrimination on the basis of age, race, religion, ethnicity, national origin, gender/sexual orientation, disability or familial status.

ewer backups and flooding can cause devastating property damage and are not covered by standard homeowners' insurance policies. The majority of these claims are the responsibility of the property owner.

Sewage from sanitary sewer lines occasionally back up into houses through drain pipes. These backups not only cause extensive water damage that is difficult and expensive to repair, but also creates health hazards.

Haverford Township is not responsible for damages caused by sewers, drains and sump pumps except under limited/ special circumstances provided by the PA Municipal Immunity laws.

Township residents must be aware that they should review their homeowner's, flood and sewer backup insurance coverage with their agent/insurance companies in order to properly protect their personal residence probably the most valuable tangible asset that we all have.

Article I, Section 149-3, subsection C (2) Sewer Service Regulations of the Township Code states that all sewer service I aterals from the Township's sewer, regardless of location, are the property of the customer and/ or owner and shall be maintained by him in good condition and repair. Please pay particular attention to the following coverages:

Coverage for Sewers, Drains and Sump Pumps: This valuable coverage is not included under your standard homeowner's policy but can be purchased by endorsement for an additional premium.

Flood Coverage:

Flood coverage is not included under your homeowner's policy. However, flood insurance is available under the National Flood Insurance Program (NFIP) and can be obtained through your insurance agent or broker.

The Township does not provide flood insurance.


ummer is the time of plans and projects and below in this article, we will tell you what is trending around town.

Comprehensive Plan Update:

In response to the recommendations of the Planning Commission, and comments presented by residents, business owners, and various community groups, the Board of Commissioners have created a finishing committee to revise the Comprehensive Plan draft, prior to holding a Public Hearing.

Trails, Parks & Intersections:

Also in the works are many upgrades to the Haverford Township trail systems starting with the Pennsy Trail. This project looks to extend the trail from Eagle Road to West Chester Pike. The extension bridges Manoa Road and goes to the Llanerch Shopping Center. Construction is expected to start in 2023 and be completed in early 2024.





Along with the Burmont and Glendale Road intersection improvements, the Brynford Bike and Pedestrian Safety Study is ongoing. The Township has gathered a focus group of locals to the Brynford area, police personnel, and consultants to investigate how to make this area safe for all who travel.



The Brookline Park Master Draft plan was front and center during the April Board of Commissioners meeting. Included in the presentation were mock-ups of the varied usage that the park could have, layouts for open space, trails, and playgrounds. Also included in the presentation was an estimated cost of development and how local and state funding could be used to create this new space.

As if all of this wasn't enough, the Township is in the mist of a Park, Recreation, and Open Space Plan that will help identify a township-wide vision for its parks, recreation services, open spaces, and trails. This is a resident-driven approach to making decisions that will enrich the future of our community and positively affect the lives of its residents.

<u>Library Expansion & Renovation Plan:</u>

Back on track is the Library's expansion and renovation plan. During February's Board of Commissioners meeting, the staff of the library presented a great PowerPoint presentation outlining how the new spaces would look and how the current users will benefit. This plan included information based on community surveys and suggestions.

With so many projects in the works, you can find more information about all current projects on the Township's website. Most of the projects listed above have their own page or will be coming soon. HTPD SAFETY TIPS

ith summertime upon us, Haverford Police wants to share some safety tips for pedestrians using crosswalks from PennDOT.

Generally, pedestrians may cross the street at any point, but pedestrians and motorists must understand their responsibilities. Below are the basic laws to follow when crossing the street or driving.

- When a pedestrian crosses the street in a crosswalk, the driver must yield.
- Drivers are not required to yield until you begin to step into the crosswalk.
- Pedestrians should not walk or run unexpectedly into the path of a moving vehicle. Pedestrians should not assume drivers will see or yield. Look left, right, and left again before stepping out.
- It is illegal for drivers to pass a vehicle that is stopped for a pedestrian in a crosswalk, as the second driver may not see the pedestrian in the crosswalk.
- If a pedestrian crosses the street (not at an intersection) and there is no crosswalk, the pedestrian must yield to vehicles.
- When crossing the street at a signalized intersection, both pedestrians and motorists must obey the traffic-control devices as these signs and signals help identify who must yield.
- When walking along a road with sidewalks and its use is practical, it is unlawful for any pedestrian to walk in the adjacent roadway.

n sweltering, hot days, nothing feels better than to sprawl in front of a chilly air conditioner. Air conditioners make it possible to live comfortably indoors during hot spring and summer months. One of the downsides of owning an air conditioner, though, is disposing of it. Our world is long past the days when a person can toss an A/C in the trash in good conscience—or even legally.

But is it really that harmful and why? If so, how do you dispose of these bulky appliances the correct way?

The first thing to know is TO NOT throw your air conditioner unit away in the regular trash. This item is considered bulk trash and you can schedule with our public works department to come pick up your unit. The reason that throwing your unit out for regular trash is harmful, is due to cooling refrigerants inside your air conditioner, which severely contribute to climate change. When you schedule a Bulk Pickup, the contractor who picks up your unit knows how to dispose of everything properly.

ummer Fire Safety Tips - Grilling Safety

There's nothing like outdoor grilling. It's one of the most popular ways to cook food. But, a grill placed too close to anything that can burn is a fire hazard. They can be very hot, causing burn injuries. Follow these simple tips and you will be on the way to safe grilling.

SAFETY TIPS

- Propane and charcoal BBQ grills should only be used outdoors.
- The grill should be placed well away from the home, deck railings and out from under eaves and overhanging branches.
- Keep children and pets at least three feet away from the grill area.
- Keep your grill clean by removing grease or fat buildup from the grills and in trays below the grill.
- Never leave your grill unattended.
- Always make sure your gas grill lid is open before lighting it.

CHARCOAL GRILLS

- There are several ways to get the charcoal ready to use. Charcoal chimney starters allow you to start the charcoal using newspaper as a fuel.
- If you use a starter fluid, use only charcoal starter fluid. Never add charcoal fluid or any other flammable liquids to the fire.
- Keep charcoal fluid out of the reach of children and away from heat sources.
- There are also electric charcoal starters, which do not use fire. Be sure to use an extension cord for outdoor use.
- When you are finished grilling, let the coals completely cool before disposing of in a metal container.

averford Township is now participating in the TerraCycle program. TerraCycle offers free recycling funded by brands, manufacturers, and retailers around the world to help collect and recycle hard-to-recycle waste.

The Township went with two collection bins that are clearly labeled and located on the left side of the main entrance of the Township building (1014 Darby Rd). One bin is for oral care which includes hard-to-recycle items like toothbrushes, toothpaste, packaging, and also floss containers. The other bin is for your personal care items like lip balm tubes, soap dispensers, and many different types of cosmetic cases.

When dropping off items to recycle, try and clean out as many unused products as possible. If you bring your items in a container or a bag, please just empty the recyclables into the appropriate bin. Please no razor blades or electric/battery-operated toothbrushes as these items are not accepted at this location.

on't forget that Haverford Township has two locations for small household electronic waste. One location is at the Township Administrative building at 1014 Darby Road and the other at the CREC parking lot at 9000 Parkview Drive. Please no large items such as appliances, microwaves, televisions, monitors, or AC units. All items must fit in the chute!

Scams on our Seniors Series (Part 2): How to Protect Yourself from Scams

. Grandparent Scam - remember this scam involves a telephone call from a person claiming to be the senior's grandchild who needs money for an emergency, usually auto repairs, or bail bond.

"Not Going to Happen to Me" Prevention Tip!

Never send a gift card to anyone you don't know. If a family member was in trouble, a legitimate law enforcement will never ask you for a gift card. If a family member is in an accident, police departments will typically notify your local police department and a request a local officer notify you.

2. Imposter Scam - remember this scam involves fraudsters who call and falsely claim they are from the IRS or a government agency and ask for money to pay taxes or a balance due.

"Not Going to Happen to Me" Prevention Tip!

Unless you have a teleconference set up with a federal employee (confirmation usually sent via a letter); hang up if someone calls and states they are from a government agency. Government officials will NEVER ask you to send money over the phone so NEVER provide banking information or credit card information.

3. Computer Scams and Phishing - remember this scam occurs when a fraudulent phone, email or a text message is sent designed to trick you into revealing sensitive personal information.

"Not Going to Happen to Me" Prevention Tip!

Read your emails carefully and NEVER click on any hyperlinks. If there was a problem with your account, your credit card or bank will already know your account information. Tell a caller you will call them back by using your local bank branch line or the phone number listed on the back of your credit card.

4. Sweetheart Scams - remember this scam involves preying on the heartstrings of lonely seniors.

"Not Going to Happen to Me" Prevention Tip!

Very simple -- NEVER send money to anyone you have never met in person no matter how genuine or down on their luck they seem to be.

5. Property scams with services - remember this scam involves fraudsters selling home improvement services that are never delivered.

"Not Going to Happen to Me" Prevention Tip!

Never pay a contractor upfront and always receive a contract. A good rule of thumb is 1/3 payment upon signing the contract, 1/3 upon project start and the final 1/3 upon completion. Also, get multiple estimates, ask if the contractor is registered in Pennsylvania and make sure he/she obtains a permit from the Township.

Some other "Not Going to Happen to Me" Tips..... (But if it does happen call 911!)

- Check your monthly credit card and bank statements for any unauthorized uses report any immediately!
- NEVER buy something from a random phone call and NEVER give out your banking information, social security number, or any other personal information.

an an Old House Learn New Tricks?

A team of community volunteers is helping the Haverford **Environmental Advisory** Committee (EAC) educate residents on how the new generation of "cold climate heat pumps" can comfortably cool an old home in the summer and heat it even in 5 degree weather without the need for fossil fuel backup, EAC's virtual "Heat Pumps 101" workshops cover cold climate heat pump capabilities, how to decide if its right for your home, ducted and ductless options, and other considerations like electrical panels. New Inflation Reduction Act financial incentives for heat pumps, panel upgrades, and more means there is no better time, but plan ahead before you are stuck with no heat or cool and forced to do the "same old, same old" for another 20 years.


Township residents must be aware that they should review their homeowner's, flood and sewer backup insurance coverage with their agent/insurance companies in order to properly protect their personal residence probably the most valuable tangible asset that we all have.

Article I, Section 149-3, subsection C (2) Sewer Service Regulations of the Township Code states that all sewer service lateral from the Township's sewer, regardless of location, are the property of the customer and/or owner and shall be maintained by him in good condition and repair.Please pay particular attention to the following coverages:

Coverage for Sewers, Drains and Sump Pumps: This valuable coverage is not included under your standard homeowner's policy but can be purchased by endorsement for an additional premium.

Flood Coverage: Flood coverage is not included under your homeowner's policy. However, flood insurance is available under the National Flood Insurance Program (NFIP) and can be obtained through your insurance agent or broker.

The Township does not provide flood insurance.





Part Two - Finance

In the Fall newsletter issue, we discussed Zoning – and we move to Finance in the Winter/Spring issue! In addition to accurately billing and collecting township property tax, sewer and trash fees for over 17,000 properties, the Finance staff handles all other facets of township finances.

We run a very efficient operation and are blessed with a dedicated staff that understands the importance of managing the Township's finances and the trust given to us. The Finance staff regularly interacts with our fellow residents, mortgage companies, and local realtors regarding township tax status, tax certifications, explanation of the property tax structure, the County assessment and appeal process, and requirements under any of the ARPA grant programs currently offered by the Township. We are also the friendly people you meet in the lobby each tax season for those property owners who prefer to pay their Township taxes in person.

More recently with the awarding of several grant programs, the Finance Department monitors spending and reporting required by the US Treasury in regards to the use of ARPA funds and we also we manage the Senior Economic Recovery Payments, Act 172 Volunteer Firefighters Credit program, and WMBE grant program to name a few others.

In addition to the billing and collection of Township property tax/sewer/trash fees, the Finance Department handles all cash receipts, banking and deposits, cash investments, all bill processing and payments, assists the Township Manager with annual budget, coordinates delinquent sewer/trash fees and lien administration, manages escrows required by land development agreements, and directs the three (3) municipal pension plans including calculation of benefits, enrollment and collaboration with the investment managers. The department also assist business owners with

the business tax filing requirements, coordinates all bond issues and manages all regulatory filings and audits (e.g. regularly scheduled Commonwealth of PA audits and the independent audit of the Township's financial statements).

So if you haven't met Chris, Jackie, Jolene, Grace or Aimee --- stop by and pay your township property taxes in person this year or we are always available for questions either in person, via email to finance@havtwp.org or by phone.

On October 26th, 2023 the Department was awarded re-accreditation by the Pennsylvania Law Enforcement Accreditation Commission. Haverford Township Police has been accredited since July 2020 and maintains compliance with over one hundred forty professional standards.



Fire Corner - Lithium-ion batteries (+ and -)

ithium-ion batteries supply power to many kinds of devices including smart phones, laptops, e-scooters and e-bikes, smoke alarms, toys, and even cars. If not used correctly or if damaged, these batteries can catch on fire or explode.

The Problem:

- These batteries store a large amount of energy in a small amount of space.
- Sometimes batteries are not used the right way;
 batteries not designed for a specific use can be dangerous.

Safety Tips:

- Always follow the manufacturer's instructions.
- Only use the battery that is designed for the device.
- Do not charge a device under your pillow, on your bed, or on a couch.
- Do not keep charging the device or device battery after it is fully charged.

Battery Disposal:

- DO NOT put lithium-ion batteries in the trash! Take them to a battery recycling location or contact the Township for disposal instructions
- DO NOT put discarded batteries in piles.

Signs of a Problem:

Stop using the battery if you notice these problems:

- odor
- too much heat
- change in color
- change in shape
- leaking
- odd noises

If a fire does occur and if safe to do so, move the device away from anything that can catch. Call 9-1-1.

Environmental Corner

Recycling Series #1: The Process and Glass

The Process:

averford's recycling is taken to Republic's King of Prussia facility. There, our comingled recycling is sorted into individual types of materials using human, mechanical, magnetic, electrical, and optical methods. The material is first placed on a conveyor where personnel quickly pull off non-recyclable and contaminated items. This includes any items contained within plastic bags. All items need to be empty and dry to properly go through the sorting process. Plastic bags and plastic film jam the conveyor belts used for moving the materials. That is why plastic bags, packing pillows, bread bags, and are only recyclable at store drop-off sites (e.g. grocery stores). After sorting, the individual materials are bailed and sold. Hoping an item can be recycled in the curbside bin, is a problem that leads to contamination and higher costs. Around 10-12% of recycling by weight is contamination. Please only recycle approved items listed in Township publications or on the website.

Glass Bottles, Jars, and Jugs:

Glass picked up curbside in Haverford Township is repurposed into landfill cover rather than recycled. Even though glass is also infinitely recyclable, commingling glass of different colors combined with food contamination issues have led our recycler and many other recycling companies to this decision. "Recycling" glass curbside is still a better option than placing it in the trash. Even better is to actually have the glass recycled by bringing it to reliable collection bins like the Pennsylvania Resources Council's Traveling Glass Bin that made an appearance at the Township Building in December. In addition, Bottle Underground, a Philly nonprofit, reuses glass. A local drop-off for Bottle Underground is available through the "Recycling Beyond the Blue Bin" program of the EAC.

Thank you for properly recycling to conserve our natural resources!

Compost Incentive

Did you know that food waste makes up 20% of our garbage? That garbage is incinerated (burned) in Chester.

To stop wasting those nutrients and to instead produce organic fertilizer, we can compost!

There are two ways to start composting in Haverford Township:

Curbside Pick-Up: Two months of free service provided to Haverford Township residents (new customers) through a grant from the USDA.
 Do It Yourself: Compost in your backyard! \$30 subsidized compost bins available for Haverford Township residents. Contact havcompost@gmail. com for training.
